Application Note:

Anti-Chicken IgG F(ab')2 is suitable for use in immunoelectrophoresis, western-blot, competitive western-blot, ELISA and competitive ELISA assays. Specific conditions for reactivity and signal detection should be optimized by the end user.

Background Information

Anti-Chicken IgG F(ab')2 Antibody generated in rabbit is a proteolytic fragment of immunoglobulin G (IgG) obtained by limited digestion with the enzyme pepsin under controlled conditions of temperature, time and pH. F(ab')2 molecules lack the Fc portion of IgG and therefore receptors that bind Chicken IgG F(c) will not bind Chicken IgG F(ab')2 molecules.

Safety Information

This reagent contains Gentamicin Sulfate (a poisonous and hazardous substance) as preservative. Although this concentration is not regarded as dangerous to health, appropriate measures should be taken to avoid skin and eye contact, inhalation, and ingestion. Standard Laboratory Practices should be followed when handling this material.DO NOT ADD SODIUM AZIDE! Use of Sodium Azide as a preservative will substantially inhibit the enzyme activity of horseradish peroxidase!
