Description:

Desmin is an intermediate filament protein of both smooth and striated muscles. Antibody to desmin reacts with striated (skeletal and cardiac) as well as smooth muscle cells. In skeletal and cardiac muscles, the staining is confined to the Z-bands giving a characteristic striated appearance. Anti-desmin antibody is useful in identification of tumors of myogenic origin.

Comments: This antibody is excellent for staining of formalin-fixed, paraffin-embedded tissues.

Mol. Wt. of Antigen: 53kDa

Epitope: Near C-terminus

Species Reactivity: Human, Mouse and Rat. Others not tested.

Immunogen:

A synthetic peptide mapping near the C-terminus of human desmin.

Applications and Suggested Dilutions:

- Western Blotting
- Immunoprecipitation
- Immunohistology (Formalin/paraffin) (Ab 1:200)
- * [No special pretreatment is required for staining of formalin/paraffin tissues.]

The optimal dilution for a specific application should be determined by the investigator.

Positive Control: Muscle or Sarcoma

Cellular Localization: Cytoplasmic

Supplied As:

Affinity purified antibody from rabbit anti-serum. Prepared in 10mM PBS, pH 7.4, with 0.2% BSA and 15mM sodium azide.

Prediluted antibody which is ready-to-use for immunohistochemical staining.

Storage and Stability:

Store vial at 4^oC. When stored at 2-8^oC, this antibody is stable for 24 months.


