The optimal working dilution should be determined by the investigator.

Buffer: 10 mM Sodium Phosphate, 0.15 M Sodium Chloride, pH 7.2

Stabilizer: 1% (w/v) Bovine Serum Albumin (IgG-free, Protease-Free)

Preservative: 0.05% (w/v) Sodium Azide

Purification: Affinity purified using solid phase Mouse IgG

Purity: > 90% based on SDS-PAGE Small amounts of intact IgG may be present.

Antibody Specificity: Based on IEP, this antibody reacts with:

heavy (γ) chains on mouse IgG

· light chains on all mouse immunoglobulins Based on IEP, no reactivity is observed to:

· non-immunoglobulin mouse serum immunoglobulins

· IgG from bovine, chicken, goat, guinea pig, hamster, horse, human, rabbit, rat or sheep

Reconstitution and Storage: Store undiluted liquid at 2-8°C. For storage at -20°C, dilute with an equal volume of glycerol

(Molecular Grade, purity >99,5%) to prevent loss of activity. Prepare working dilutions prior to use and then discard. Product is stable for up to 1 year from date of receipt. **Note:** adding glycerol reduces the stated protein concentration and dilution range by one-half. The

expiration date may be extended if test results are acceptable for the intended use.

Safety Information: Standard Laboratory Practices should be followed when handling this material. The chemical,

physical, and toxicological properties of this material have not been thoroughly investigated. The antibody contains 0.05% sodium azide (a poisonous and hazardous substance) as preservative. Although this concentration is not regarded as dangerous to health, appropriate

measures should be taken to avoid skin and eye contact, inhalation, and ingestion.
