Buffer: 10 mM Sodium Phosphate, 0.15 M Sodium Chloride, pH 7.2

Stabilizer: 1% (w/v) Bovine Serum Albumin (IgG-free, Protease-Free)

Preservative: 0.1% (v/v) Kathon CG

Purification: Affinity purified using solid phase Mouse IgG

Purity: > 90% based on SDS-PAGE Small amounts of intact IgG may be present.

Antibody Specificity: Based on IEP, this antibody reacts with:

· heavy (y) chains on mouse IgG

· light chains on all mouse immunoglobulins Based on IEP, no reactivity is observed to:

non-immunoglobulin mouse serum immunoglobulins

 \cdot IgG from bovine, chicken, goat, guinea pig, hamster, horse, human, rabbit, rat or sheep

Reconstitution and Storage: Store freeze-dried powder at 2-8 °C. Product is stable for up to 4 weeks at 2-8 °C after

rehydration. For extended storage, aliquot and freeze at - 70° C or below. Avoid repeated freezing and thawing. Alternatively, add an equal volume of glycerol (Molecular Grade, purity > 99,5%) and store at - 20° C in liquid form. **Note:** adding glycerol reduces the stated protein concentration and dilution range by one-half. Under long-term storage the rehydrated

antibody is stable for one year from date of rehydration.

Warning: Confirm that glycerol is non-contaminated and of high-quality (Molecular Grade, purity > 99,5%) before adding to this product. Use of low quality and/ or

contaminated glycerol may seriously inhibit peroxidase enzyme activity.

followed when handling this material.
