Product: Goat anti-Chicken IgY (H&L) - Affinity Pure, ALP Conjugate

Physical State: Clear, colorless liquid

Antibody Concentration: 1.50 mg/ml (E 1% at 280 nm = 13.0) (concentration lot dependent)

Conjugation: Alkaline Phosphatase

Suggested Dilution Range: 1:500 - 1:2.000 for most applications

The optimal working dilution should be determined by the investigator.

Buffer: 30 mM Triethanolamine, pH 7.2, 5 mM Magnesium Chloride, 0.1 mM Zinc Chloride

Stabilizer: 1% (w/v) Bovine Serum Albumin (IgG-free, Protease-Free)

Preservative: 0.05% (w/v) Sodium Azide

Purification: Affinity purified using solid phase Chicken IgG/Y

Purity: Affinity purified antibody is > 95% based on SDS-PAGE

Antibody Specificity: Based on IEP, this antibody reacts with:

· heavy (γ) chains on chicken IgG/Y

· light chains on all chicken immunoglobulins Based on IEP, no reactivity is observed to:

· non-immunoglobulin chicken serum immunoglobulins

Reconstitution and Storage: Store undiluted liquid at 2-8 °C. For storage at -20 °C, dilute with an equal volume of glycerol

(Molecular Grade, purity > 99,5%) to prevent loss of enzymatic activity. Prepare working dilutions prior to use and then discard. Product is stable for up to 1 year from date of receipt. **Note:** adding glycerol reduces the stated protein concentration and dilution range by one-half. Use of low quality glycerol may affect conjugate activity. The expiration date may be

extended if test results are acceptable for the intended use.

Safety Information: Standard Laboratory Practices should be followed when handling this material. The chemical,

physical, and toxicological properties of this material have not been thoroughly investigated. The antibody contains 0.05% sodium azide (a poisonous and hazardous substance) as preservative. Although this concentration is not regarded as dangerous to health, appropriate

measures should be taken to avoid skin and eye contact, inhalation, and ingestion.
