**Preservative:** 0.05% (w/v) Sodium Azide

**Purification:** Affinity purified using solid phase Chicken IgG/Y

**Purity:** Affinity purified antibody is > 95% based on SDS-PAGE

Antibody Specificity: Based on IEP, this antibody reacts with:

· heavy (y) chains on chicken IgG/Y

· light chains on all chicken immunoglobulins Based on IEP, no reactivity is observed to:

non-immunoglobulin chicken serum immunoglobulins

**Reconstitution and Storage:** Store undiluted liquid at 2-8°C. For storage in liquid form at -20°C, dilute with an equal volume

of glycerol (Molecular Grade, purity >99,5%) to prevent loss of activity. Product is stable for up to 1 year from date of receipt. Prepare working dilution prior to use and then discard. **Note:** adding glycerol reduces the stated protein concentration and dilution range by one-

nait.

physical, and toxicological properties of this material have not been thoroughly investigated. The antibody contains 0.05% sodium azide (a poisonous and hazardous substance) as preservative. Although this concentration is not regarded as dangerous to health, appropriate
