**Product:** Goat anti-Human IgG Fc - Affinity Pure, HRP Conjugate

Physical State: Lyophilized

**Size:** 1.0 mg

Antibody Concentration: 1.0 mg/ml (E 1% at 280 nm = 13.2) (concentration lot dependent)

Conjugation: Horseradish Peroxidase

**Suggested Dilution Range:** 1:500 - 1:5.000 for most applications

The optimal working dilution should be determined by the investigator.

**Buffer:** 10 mM Sodium Phosphate, 0.15 M Sodium Chloride, pH 7.2

Stabilizer: 1% (w/v) Bovine Serum Albumin (IgG-free, Protease-Free)

**Preservative:** 0.1% (v/v) Kathon CG

**Purification:** Affinity purified using solid phase Human IgG

**Purity:** Affinity purified antibody is > 95% based on SDS-PAGE.

**Antibody Specificity:** Based on IEP, this antibody reacts with:

heavy (γ) chains on human IgG

Based on IEP, no reactivity is observed to:

· non-immunoglobulin human serum immunoglobulins

· light chains on all human immunoglobulins

Reconstitution and Storage: Store freeze-dried powder at 2-8 °C. Rehydrate with 1.1 ml of deionized water and let stand

30 minutes at room temperature to dissolve. (Product has been overfilled to ensure complete recovery.) Centrifuge to remove any particulates. Prepare fresh working dilution daily. Product is stable for up to 4 weeks at 2-8°C after rehydration. For extended storage, aliquot and freeze at -70°C or below. Avoid repeated freezing and thawing. Alternatively, add an equal volume of glycerol (Molecular Grade, purity > 99,5%) and store at -20°C in liquid form. **Note:** adding glycerol reduces the stated protein concentration and dilution range by one-half. Under long-term storage the rehydrated antibody is stable for one year from date of

rehydration.

Warning: Confirm that glycerol is non-contaminated and of high-quality (Molecular Grade, purity > 99,5%) before adding to this product. Use of low quality and/ or

contaminated glycerol may seriously inhibit peroxidase enzyme activity.

Safety Information: The product contains no hazardous constituents. Standard Laboratory Practices should be

followed when handling this material.
