Buffer: 10 mM Sodium Phosphate, 0.15 M Sodium Chloride, pH 7.2

Stabilizer: 1% (w/v) Bovine Serum Albumin (IgG-free, Protease-Free)

Preservative: 0.05% (w/v) Sodium Azide

Purification: Affinity purified using solid phase Human IgM

Purity: Affinity purified antibody is > 95% based on SDS-PAGE

Antibody Specificity: Based on IEP, this antibody reacts with:

· heavy (µ) chains on human IgM

Based on IEP, no reactivity is observed to: non-immunoglobulin human serum proteins light chains on all human immunoglobulins

Reconstitution and Storage: Store undiluted liquid at 2-8°C. For storage in liquid form at -20°C, dilute with an equal volume

of glycerol (Molecular Grade, purity >99,5%) to prevent loss of activity. Product is stable for up to 1 year from date of receipt. Prepare working dilution prior to use and then discard. **Note:** adding glycerol reduces the stated protein concentration and dilution range by one-

nait.

Standard Laboratory Practices should be followed when handling this material. The chemical,

physical, and toxicological properties of this material have not been thoroughly investigated. The antibody contains 0.05% sodium azide (a poisonous and hazardous substance) as preservative. Although this concentration is not regarded as dangerous to health, appropriate
