Reconstitution and Storage:	Store freeze-dried powder at 2-8 °C. Product is stable for up to 4 weeks at 2-8°C after rehydration. For extended storage, aliquot and freeze at -70°C or below. Avoid repeated freezing and thawing. Alternatively, add an equal volume of glycerol (Molecular Grade, purity > 99,5%) and store at -20°C in liquid form. Note: adding glycerol reduces the stated protein concentration and dilution range by one-half. Under long-term storage the rehydrated antibody is stable for one year from date of rehydration. Warning: Confirm that glycerol is non-contaminated and of high-quality (Molecular Grade, purity > 99,5%) before adding to this product. Use of low quality and/ or contaminated glycerol may seriously inhibit peroxidase enzyme activity.
