Product is stable for up to 1 year from date of receipt. <b>Note:</b> adding glycerol reduces the stated protein concentration and dilution range by one-half. Use of low quality glycerol may affect conjugate activity. The expiration date may be extended if test results are acceptable for the intended use. |

The antibody contains 0.05% sodium azide (a poisonous and hazardous substance) as preservative.
