**Preservative:** 0.05% (w/v) Sodium Azide

**Purification:** Affinity purified using solid phase Rabbit IgG

**Purity:** Affinity purified antibody is > 95% based on SDS-PAGE

Antibody Specificity: Based on IEP, this antibody reacts with:

· heavy (γ) chains on rabbit IgG

· light chains on all rabbit immunoglobulins
 Based on IEP, no reactivity is observed to:
 · non-immunoglobulin rabbit serum proteins
 · serum proteins from bovine, human, or mouse

IgG from human or mouse

Reconstitution and Storage: Store undiluted liquid at 2-8°C. For storage in liquid form at -20°C, dilute with an equal volume

of glycerol (Molecular Grade, purity >99,5%) to prevent loss of activity. Product is stable for up to 1 year from date of receipt. Prepare working dilution prior to use and then discard. **Note:** adding glycerol reduces the stated protein concentration and dilution range by one-

าalf.
