| Reconstitution and Storage: | Store undiluted liquid at 2-8°C. For storage at -20°C, dilute with an equal volume of glycerol (Molecular Grade, purity >99,5%) to prevent loss of activity. Prepare working dilutions prior to use and then discard. Product is stable for up to 1 year from date of receipt. Note: adding glycerol reduces the stated protein concentration and dilution range by one-half. The expiration date may be extended if test results are acceptable for the intended use. |
| Safety Information: | Standard Laboratory Practices should be followed when handling this material. The chemical, physical, and toxicological properties of this material have not been thoroughly investigated. The antibody contains 0.05% sodium azide (a poisonous and hazardous substance) as preservative.
