The optimal working dilution should be determined by the investigator.

Buffer: 10 mM Sodium Phosphate, 0.15 M Sodium Chloride, pH 7.2

Stabilizer: 1% (w/v) Bovine Serum Albumin (IgG-free, Protease-Free)

Preservative: 0.05% (w/v) Sodium Azide

Purification: Affinity purified using solid phase Rat IgG

Purity: Affinity purified antibody is > 95% based on SDS-PAGE

Antibody Specificity: Based on IEP, this antibody reacts with:

· heavy (γ) chains on rat IgG

· light chains on all rat immunoglobulins Based on IEP, no reactivity is observed to: · non-immunoglobulin rat serum proteins

IgG from Goat, Hamster, Human, Mouse, or Rabbit

· Serum from Bovine, Goat, Horse, Human, Mouse, or Rabbit

Reconstitution and Storage: Store freeze-dried powder at 2-8 °C. Rehydrate with 1.1 ml of deionized water and let stand

30 minutes at room temperature to dissolve. (Product has been overfilled to ensure complete recovery.) Centrifuge to remove any particulates. Prepare fresh working dilution daily. Product is stable for up to 4 weeks at 2-8°C after rehydration. For extended storage, aliquot and freeze at -70°C or below. Avoid repeated freezing and thawing of antibody solution. Alternatively, add an equal volume of glycerol (Molecular Grade, purity > 99,5%) and store at -20°C in liquid form. **Note:** adding glycerol reduces the stated protein concentration and dilution range by one-half. Under long-term storage the rehydrated antibody is stable for one year from date of rehydration. The expiration date may be extended if test results are

acceptable for the intended use.

Safety Information: Standard Laboratory Practices should be followed when handling this material. The chemical,

physical, and toxicological properties of this material have not been thoroughly investigated. The antibody contains 0.05% sodium azide (a poisonous and hazardous substance) as preservative. Although this concentration is not regarded as dangerous to health, appropriate

measures should be taken to avoid skin and eye contact, inhalation, and ingestion.
