Buffer: 30 mM Triethanolamine, pH 7.2, 5 mM Magnesium Chloride, 0.1 mM Zinc Chloride

Stabilizer: 1% (w/v) Bovine Serum Albumin (IgG-free, Protease-Free)

Preservative: 0.05% (w/v) Sodium Azide

Purification: Affinity purified using solid phase Rat IgG

Purity: > 90% based on SDS-PAGE. Small amounts of intact IgG may be present.

Antibody Specificity: Based on IEP, this antibody reacts with:

· heavy (γ) chains on rat IgG

· light chains on all rat immunoglobulins Based on IEP, no reactivity is observed to: · non-immunoglobulin rat serum proteins

IgG from goat, hamster, human, mouse, or rabbit

· serum from bovine, goat, horse, human, mouse, or rabbit

Reconstitution and Storage: Store undiluted liquid at 2-8°C. For storage in liquid form at -20°C, dilute with an equal volume

of glycerol (Molecular Grade, purity >99,5%) to prevent loss of activity. Product is stable for up to 1 year from date of receipt. Prepare working dilution prior to use and then discard. **Note:** adding glycerol reduces the stated protein concentration and dilution range by one-

nalf.

physical, and toxicological properties of this material have not been thoroughly investigated. The antibody contains 0.05% sodium azide (a poisonous and hazardous substance) as preservative.
