(Product has been overfilled to ensure complete recovery.) Centrifuge to remove any particulates. Prepare fresh working dilution daily. Product is stable for up to 4 weeks at 2-8°C after rehydration. For extended storage after rehydration, add an equal volume of glycerol (Molecular Grade, purity > 99,5%) for a final concentration of 50%, and store at -20°C in liquid form. <b>Note:</b> adding glycerol reduces the stated protein concentration and dilution range by one-half. Under long-term storage the rehydrated antibody is stable for one year from date of rehydration. The expiration date may be extended if test results are acceptable for the intended use. |

The chemical, physical, and toxicological properties of this material have not been thoroughly investigated. The antibody contains 0.05% sodium azide (a poisonous and hazardous substance) as preservative.
