Preservative: 0.05% (w/v) Sodium Azide

Purification: Affinity purified using solid phase Mouse IgG

Purity: Affinity purified antibody is > 95% based on SDS-PAGE

Antibody Specificity: Based on IEP, this antibody reacts with:

· heavy (y) chains on mouse IgG

· light chains on all mouse immunoglobulins Based on IEP, no reactivity is observed to: non-immunoglobulin mouse serum proteins

· human serum proteins

Reconstitution and Storage: Store undiluted liquid at 2-8°C. For storage in liquid form at -20°C, dilute with an equal volume

of glycerol (Molecular Grade, purity >99,5%) to prevent loss of activity. Product is stable for up to 1 year from date of receipt. Prepare working dilution prior to use and then discard. Note: adding glycerol reduces the stated protein concentration and dilution range by one-
