Reconstitution and Storage:	Store undiluted liquid at 2-8°C. For storage in liquid form at -20°C, dilute with an equal volume of glycerol (Molecular Grade, purity >99,5%) to prevent loss of activity. Product is stable for up to 1 year from date of receipt. Prepare working dilution prior to use and then discard. Note: adding glycerol reduces the stated protein concentration and dilution range by one-half.
Safety Information:	Standard Laboratory Practices should be followed when handling this material. The chemical, physical, and toxicological properties of this material have not been thoroughly investigated. The antibody contains 0.05% sodium azide (a poisonous and hazardous substance) as preservative.
