<b>Product:</b>	Peroxidase-ChromPure Chicken IgY (IgG), whole molecule

<b>Purity:</b>	Based on immunoelectrophoresis at an antigen concentration of 20 mg/ml, the pattern of precipitation against anti-chicken whole serum is the same as that against anti-chicken IgY, Fc fragment specific.
<b>Reconstitution and Storage:</b>	<p>Store freeze-dried powder at 2-8°C. When ready to use, rehydrate with 1.1 ml dH<sub>2</sub>O and centrifuge if not clear. Product is stable for about 6 weeks at 2-8°C as an undiluted liquid. Prepare working dilution fresh each day. For extended storage after rehydration, aliquot and freeze at -70°C or below. Avoid repeated freezing and thawing. Alternatively, add an equal volume of glycerol (ACS grade or better) for a final concentration of 50%, and store at -20°C as a liquid. Note: adding glycerol reduces the stated protein concentration and dilution range by one-half.</p> <p>Expiration date: one year from date of rehydration. The expiration date may be extended if test results are acceptable for the intended use.</p> <p>(Warning: Confirm that glycerol is ACS grade or better before adding to this product. Lower grades of glycerol may seriously inhibit peroxidase enzyme activity.)</p>
<b>Safety Information:</b>	This product contains no substances considered to be hazardous to health. Although the product is classified as non-hazardous, Standard Laboratory Practices should be followed when handling this material.
