Product: Peroxidase-ChromPure Human IgM (myeloma), whole molecule

Physical State: Freeze-dried solid

Size: 1.0 mg (This product has been overfilled to ensure total recovery of stated quantity.)

IgM Concentration: 1.0 mg/ml

Peroxidase: Purified from horseradish root

Buffer: 0.01M Sodium Phosphate, 0.25M NaCl, pH 7.6

Stabilizer: 15 mg/ml Bovine Serum Albumin (lgG-Free, Protease-Free)

Preservative: None (Warning: Use of sodium azide as a preservative will substantially inhibit the enzyme

activity of horseradish peroxidase.)

Purity: Based on immunoelectrophoresis at an antigen concentration of 20 mg/ml, the pattern of

precipitation against anti-human whole serum is the same as that against anti-human IgM, Fc5µ fragment specific. No precipitin line was detected against anti-human IgG, Fc fragment

specific; anti-human IgA, α chain specific; or anti-human alpha-2 macroglobulin.

Reconstitution and Storage: Store freeze-dried powder at 2-8°C. When ready to use, rehydrate with 1.1 ml dH2O and

centrifuge if not clear. Product is stable for about 6 weeks at 2-8°C as an undiluted liquid. Prepare working dilution fresh each day. For extended storage after rehydration, aliquot and freeze at -70°C or below. Avoid repeated freezing and thawing. Alternatively, add an equal volume of glycerol (ACS grade or better) for a final concentration of 50%, and store at -20°C as a liquid. Note: adding glycerol reduces the stated protein concentration and dilution range

by one-half.

Expiration date: one year from date of rehydration. The expiration date may be extended if test

results are acceptable for the intended use.

(Warning: Confirm that glycerol is ACS grade or better before adding to this product. Lower

grades of glycerol may seriously inhibit peroxidase enzyme activity.)

Safety Information: This product contains no substances considered to be hazardous to health. Although the

product is classified as non-hazardous, Standard Laboratory Practices should be followed

when handling this material.
