| <b>Reconstitution and Storage:</b> | Store freeze-dried powder at 2-8°C. When ready to use, rehydrate with 0.55 ml dH <sub>2</sub> O and centrifuge if not clear. Product is stable for about 6 weeks at 2-8°C as an undiluted liquid. Prepare working dilution fresh each day. For extended storage after rehydration, aliquot and freeze at -70°C or below. Avoid repeated freezing and thawing. Alternatively, add an equal volume of glycerol (ACS grade or better) for a final concentration of 50%, and store at -20°C as a liquid. Note: adding glycerol reduces the stated protein concentration and dilution range by one-half.<br>Expiration date: one year from date of rehydration. The expiration date may be extended if test results are acceptable for the intended use. |
| <b>Safety Information:</b>         | Standard Laboratory Practices should be followed when handling this material. The chemical, physical, and toxicological properties of this material have not been thoroughly investigated. The antibody contains 0.05% sodium azide (a poisonous and hazardous substance) as preservative.
