Preservative: None (Warning: Use of sodium azide as a preservative will substantially inhibit the enzyme

activity of horseradish peroxidase.)

**Purity:** The antibody was purified from antisera by immunoaffinity chromatography using antigens

coupled to agarose beads.

**Antibody Specificity:** Based on immunoelectrophoresis and/or ELISA, the antibody reacts with the F(ab')2/Fab

portion of rabbit IgG. It also reacts with the light chains of other rabbit immunoglobulins. No antibody was detected against the Fc portion of rabbit IgG or against non-immunoglobulin serum proteins. The antibody has been tested by ELISA and/or solid phase adsorbed to ensure minimal cross-reaction with human serum proteins, but it may cross-react with

immunoglobulins from other species.

Reconstitution and Storage: Store freeze-dried powder at 2-8°C. When ready to use, rehydrate with 1.5 ml dH2O and

centrifuge if not clear. Product is stable for about 6 weeks at 2-8°C as an undiluted liquid. Prepare working dilution fresh each day. For extended storage after rehydration, aliquot and freeze at -70°C or below. Avoid repeated freezing and thawing. Alternatively, add an equal volume of glycerol (ACS grade or better) for a final concentration of 50%, and store at -20°C as a liquid. Note: adding glycerol reduces the stated protein concentration and dilution range by one-half.

Expiration date:one year from date of rehydration. The expiration date may be extended if test

results are acceptable for the intended use.

(Warning: Confirm that glycerol is ACS grade or better before adding to this product. Lower

grades of glycerol may seriously inhibit peroxidase enzyme activity.)

Safety Information: This product contains no substances considered to be hazardous to health. Although the

product is classified as non-hazardous, Standard Laboratory Practices should be followed

when handling this material.
