Antibody Specificity:	Based on antigen-binding assay and/or ELISA, the antibody reacts with the Fc portion of mouse IgG2c but not with other mouse IgG subclasses, mouse IgM, or the Fab portion of mouse immunoglobulins. No antibody was detected against non-immunoglobulin serum proteins. The antibody has been tested by ELISA and/or solid-phase adsorbed to ensure minimal cross-reaction with human, bovine, and rabbit serum proteins, but it may cross-react with immunoglobulins from other species.
Reconstitution and Storage:	Store freeze-dried solid at 2-8°C. Rehydrate with 0.5 ml dH ₂ O and centrifuge if not clear. Store at 2-8°C - do not freeze. Prepare working dilution on day of use. Expiration date:six months from date of rehydration. The expiration date may be extended if test results are acceptable for the intended use.
Safety Information:	Standard Laboratory Practices should be followed when handling this material. The chemical, physical, and toxicological properties of this material have not been thoroughly investigated. The antibody contains 0.05% sodium azide (a poisonous and hazardous substance) as preservative. Although this concentration is not regarded as dangerous to health, appropriate measures should be taken to avoid skin and eye contact, inhalation, and ingestion.
