Purity:	The antibody was purified from antisera by a combination of pepsin digestion and immunoaffinity chromatography using antigens coupled to agarose beads. Fc fragments and whole IgG molecules have been removed.
Antibody Specificity:	Based on immunoelectrophoresis and/or ELISA, the antibody reacts with both mouse IgG and IgM. It also reacts with the light chains of other mouse immunoglobulins. No antibody was detected against non-immunoglobulin serum proteins. The antibody has been tested by ELISA and/or solid-phase adsorbed to ensure minimal cross-reaction with human, bovine, and horse serum proteins, but it may cross-react with immunoglobulins from other species.
Reconstitution and Storage:	Store freeze-dried solid at 2-8°C. Rehydrate with 0.5 ml dH2O and centrifuge if not clear. Store at 2-8°C - do not freeze. Prepare working dilution on day of use. Expiration date:six months from date of rehydration. The expiration date may be extended if test results are acceptable for the intended use.
Safety Information:	Standard Laboratory Practices should be followed when handling this material. The chemical, physical, and toxicological properties of this material have not been thoroughly investigated. The antibody contains 0.05% sodium azide (a poisonous and hazardous substance) as
