Product: Alexa Fluor® 790-AffiniPure Fab Fragment Goat Anti-Mouse IgG1, Fcy Fragment Specific

Antibody Concentration: ± 1.8 mg/ml (exact concentration lot dependent)

Amax = 792 nm; Emax = 803 nm

Suggested Dilution Range: 1:100 - 1:800 for sequential staining applications. To complex with primary antibody in solution,

use 1:1 weight ratio of Fab:primary antibody (3:1 molar ratio). Vortex and incubate for 30 minutes at room temperature prior to use. Titrate complex to optimal dilution for assay.

Buffer: 0.01M Sodium Phosphate, 0.25M NaCl, pH 7.6

Stabilizer: 15 mg/ml Bovine Serum Albumin (IgG-Free, Protease-Free)

Preservative: 0.05% Sodium Azide

Purity: The antibody was purified from antisera by a combination of papain digestion and

immunoaffinity chromatography using antigens coupled to agarose beads. Fc fragments and

whole IgG molecules have been removed.

Antibody Specificity: Based on antigen-binding assay and/or ELISA, the antibody reacts with the Fc portion of

mouse IgG1 but not with the Fab portion of mouse immunoglobulins. No antibody was detected against mouse IgM or against non immunoglobulin serum proteins. The antibody may cross-

react with other mouse IgG subclasses or with immunoglobulins from other species.

Reconstitution and Storage: Store freeze-dried powder at 2-8°C. When ready to use, rehydrate with 0.5 ml dH2O (exact

volume is lot specific) and centrifuge if not clear. Product is stable for about 6 weeks at 2-8°C as an undiluted liquid. Prepare working dilution fresh each day. For extended storage after rehydration, aliquot and freeze at -70°C or below. Avoid repeated freezing and thawing. Alternatively, add an equal volume of glycerol (ACS grade or better) for a final concentration of 50%, and store at -20°C as a liquid. Note: adding glycerol reduces the stated protein

concentration and dilution range by one-half.

Expiration date:one year from date of rehydration. The expiration date may be extended if test

results are acceptable for the intended use.

Safety Information: Standard Laboratory Practices should be followed when handling this material. The chemical,

physical, and toxicological properties of this material have not been thoroughly investigated. The antibody contains 0.05% sodium azide (a poisonous and hazardous substance) as preservative. Although this concentration is not regarded as dangerous to health, appropriate

measures should be taken to avoid skin and eye contact, inhalation, and ingestion.
