Purity: The antibody was purified from antisera by immunoaffinity chromatography using antigens

coupled to agarose beads.

Antibody Specificity: Based on immunoelectrophoresis and/or ELISA, the antibody reacts with whole molecule

alpaca IgG, and with llama IgG. The antibody reacts primarily with the Fc region, and is not recommended for detection of VHH antibodies. No antibody was detected against non-immunoglobulin serum proteins. The antibody may cross-react with immunoglobulins from

other species.

Reconstitution and Storage: Store freeze-dried powder at 2-8°C. When ready to use, rehydrate with 0.75 ml dH2O (exact

volume is lot specific) and centrifuge if not clear. Product is stable for about 6 weeks at 2-8°C as an undiluted liquid. Prepare working dilution fresh each day. For extended storage after rehydration, aliquot and freeze at -70°C or below. Avoid repeated freezing and thawing. Alternatively, add an equal volume of glycerol (ACS grade or better) for a final concentration of 50%, and store at -20°C as a liquid. Note: adding glycerol reduces the stated protein

concentration and dilution range by one-half.

Expiration date: one year from date of rehydration. The expiration date may be extended if test results are acceptable for the intended use. Store freeze-dried powder at 2-8°C. When ready to use, rehydrate with 0.75 ml dH2O (exact volume is lot specific) and centrifuge if not clear. Product is stable for about 6 weeks at 2-8°C as an undiluted liquid. Prepare working dilution fresh each day. For extended storage after rehydration, aliquot and freeze at -70°C or below. Avoid repeated freezing and thawing. Alternatively, add an equal volume of glycerol (ACS grade or better) for a final concentration of 50%, and store at -20°C as a liquid. Note: adding

glycerol reduces the stated protein concentration and dilution range by one-half.

Expiration date:one year from date of rehydration. The expiration date may be extended if test

results are acceptable for the intended use.

Safety Information: Standard Laboratory Practices should be followed when handling this material. The chemical,

physical, and toxicological properties of this material have not been thoroughly investigated. The antibody contains 0.05% sodium azide (a poisonous and hazardous substance) as preservative. Although this concentration is not regarded as dangerous to health, appropriate

measures should be taken to avoid skin and eye contact, inhalation, and ingestion.
