Buffer: 0.01M Sodium Phosphate, 0.25M NaCl, pH 7.6

Stabilizer: 15 mg/ml Bovine Serum Albumin (IgG-Free, Protease-Free)

Preservative: None (Warning: Use of sodium azide as a preservative will substantially inhibit the enzyme

activity of horseradish peroxidase.)

Purity: The antibody was purified from antisera by a combination of pepsin digestion and

immunoaffinity chromatography using antigens coupled to agarose beads. Fc fragments and

whole IgG molecules have been removed.

Antibody Specificity: Based on immunoelectrophoresis and/or ELISA, the antibody reacts with whole molecule

human IgG. It also reacts with the light chains of other human immunoglobulins. No antibody was detected against non immunoglobulin serum proteins. The antibody has been tested by ELISA and/or solid-phase adsorbed to ensure minimal cross-reaction with bovine, chicken, goat, guinea pig, Syrian hamster, horse, mouse, rabbit, rat, and sheep serum proteins, but it

may cross-react with immunoglobulins from other species.

Reconstitution and Storage: Store freeze-dried powder at 2-8°C. When ready to use, rehydrate with 0.3 ml dH2O and

centrifuge if not clear. Product is stable for about 6 weeks at 2-8°C as an undiluted liquid. Prepare working dilution fresh each day. For extended storage after rehydration, aliquot and freeze at -70°C or below. Avoid repeated freezing and thawing. Alternatively, add an equal volume of glycerol (ACS grade or better) for a final concentration of 50%, and store at -20°C as a liquid. Note: adding glycerol reduces the stated protein concentration and dilution range

by one-half.

Expiration date one year from date of rehydration. The expiration date may be extended if test

results are acceptable for the intended use.

(Warning: Confirm that glycerol is ACS grade or better before adding to this product. Lower

grades of glycerol may seriously inhibit peroxidase enzyme activity.)

Safety Information: This product contains no substances considered to be hazardous to health. Although the

product is classified as non-hazardous, Standard Laboratory Practices should be followed

when handling this material.
