No antibody was detected against non-immunoglobulin serum proteins. The antibody has been tested by ELISA and/or solid-phase adsorbed to ensure minimal cross-reaction with bovine, chicken, goat, guinea pig, Syrian hamster, horse, human, mouse, rabbit, and sheep serum proteins, but it may cross-react with immunoglobulins from other species.
<b>Storage:</b>	Store at 2-8°C under sterile conditions. Prepare working dilution fresh each day. Expiration date: one year from date of receipt. The expiration date may be extended if test results are acceptable for the intended use.
<b>Safety Information:</b>	This product contains no substances considered to be hazardous to health. Although the product is classified as non-hazardous, Standard Laboratory Practices should be followed when handling this material.
