Antibody Specificity: IgG (H+L)	This product is a F(ab') ₂ fragment of an IgG fraction antibody purified from monospecific antiserum by a multi-step process which includes delipidation, salt fractionation, ion exchange chromatography and pepsin digestion followed by extensive dialysis against the buffer stated above. Assay by immunoelectrophoresis resulted in a single precipitin arc against anti-Peroxidase, anti-Rabbit Serum, Horse IgG and Horse Serum. No reaction was observed against anti-Rabbit IgG F(c) or anti-Pepsin.

Formulation, Transport and Storage

Storage Buffer: 0.01 M Sodium Phosphate, 0.15 M Sodium Chloride, pH 7.2	Store vial at 4° C prior to restoration. For extended storage aliquot contents and freeze at -20° C or below. Avoid cycles of freezing and thawing. Centrifuge product if not completely clear after standing at room temperature. This product is stable for several weeks at 4° C as an undiluted liquid. Dilute only prior to immediate use.

Application Note:

This product has been assayed against 1.0 ug of Horse IgG in a standard capture ELISA using ABTS (2,2'-azino-bis-[3-ethylbenthiiazoline-6-sulfonic acid]) code # ABTS-100 as a substrate for 30 minutes at room temperature. A working dilution of 1:20,000 to 1:100,000 of the reconstitution concentration is suggested for this product.

Background Information

F(ab')₂ Anti-Horse IgG Fluorecsein Antibody was generated by enzymatic cleavage and subsequent separation from the Fc fragment. Because of their smaller size, F(ab)₂ fragments offer several advantages over intact antibodies for use in certain immunochemical techniques and experimental applications. F(ab)₂ fragments penetrate tissue samples and show better antigen recognition and signal generation in IHC. F(ab)₂ fragments lack the Fc region and therefore do not bind Fc receptors which effectively lowers background staining. F(ab')₂ Antibody is ideal for investigators who routinely perform flow cytometry, immunohistochemistry or IHC and other immunoassays.

The product contains no hazardous constituents. Standard Laboratory Practices should be followed when handling this material. **DO NOT ADD SODIUM AZIDE!** Use of Sodium Azide as a preservative will substantially inhibit the enzyme activity of horseradish peroxidase!
