Anti-Human k (kappa chain) Antibody has been prepared from monospecific antisera by immunoaffinity chromatography using Human Kappa coupled to agarose beads. Specificity was confirmed by ELISA. In order to assure specificity cross-adsorptions were performed against a panel of Human IgM Lambda, Human IgG Lambda and Human IgA Lambda proteins.

Application Recommendation

Store vial at 4° C prior to restoration. For extended storage aliquot contents and freeze at -20° C or below. Avoid cycles of freezing and thawing. Centrifuge product if not completely clear after standing at room temperature. This product is stable for several weeks at 4° C as an undiluted liquid. Dilute only prior to immediate use.

Storage Temperature: 4-8°C

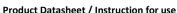

Application Note:

This secondary Anti-Human k (kappa chain) Antibody is ideal for investigators who routinely perform titration assays, western-blot, immunoprecipitation and more generally immunoassays. Anti-human kappa chain Antibody has been assayed against 1.0 ug of human kappa light chain in a standard capture ELISA using ABTS (2,2'-azino-bis-[3-ethylbenthiazoline-6sulfonic acid]) code # ABTS-100 as a substrate for 30 minutes at room temperature. A working dilution of 1:2,000 to 1:8,000 of the reconstitution concentration is suggested for this product.

Background Information

The anti-Human κ (kappa chain) Antibody detects the kappa chain subunit. Immunoglobulins are heterotetramers composed of 2 immunoglobulin heavy and 2 immunoglobulin light chains. The immunoglobulin light chain is the small polypeptide subunit of an antibody (immunoglobulin). In humans the light chains can be categorized into kappa type or lambda type and both are used to construct the antigen binding F(ab) region of an antibody along with the variable region of the heavy chain. Secondary Antibodies are available in a variety of formats and conjugate types. When choosing a secondary antibody product, consideration must be given to species and immunoglobulin specificity, conjugate type, fragment and chain specificity, level of cross-reactivity, and host-species source and fragment composition. Anti-Human IgG kappa is conjugated to HRP.

Safety Information

This reagent contains Thimerosal (a poisonous and hazardous substance) as preservative.
