Application Note:

Anti-Rabbit IgG F(c) Peroxidase conjugate is suitable for immunoblotting (western or dot blot), ELISA, immunoelectron microscopy and immunohistochemistry as well as other antibody-based enzymatic assays requiring lot-to-lot consistency.

Background Information

Anti-Rabbit IgG F(c) peroxidase antibody generated in donkey is a proteolytic fragment of immunoglobulin G (IgG) obtained by limited digestion with the enzyme papain under controlled conditions of temperature, time and pH. Receptors bind the Fc. portion of rabbit IgG and often this fragment is removed from immunoglobulins to minimize receptor binding and lower background reactivity.

Safety Information

This reagent contains Gentamicin Sulfate (a poisonous and hazardous substance) as preservative. Although this concentration is not regarded as dangerous to health, appropriate measures should be taken to avoid skin and eye contact, inhalation, and ingestion. Standard Laboratory Practices should be followed when handling this material.DO NOT ADD SODIUM AZIDE! Use of Sodium Azide as a preservative will substantially inhibit the enzyme activity of horseradish peroxidase!
