**Application Recommendation** 

Store vial at 4° C prior to restoration. For extended storage aliquot contents and freeze at -20° C or below. Avoid cycles of freezing and thawing. Centrifuge product if not completely clear after standing at room temperature. This product is stable for several weeks at 4° C as an undiluted liquid. Dilute only prior to immediate use.

#### **Application Note:**

Anti-Rabbit IgG whole molecule is suitable for use in immunoelectrophoresis, western-blot, competitive western-blot, ELISA and competitive ELISA assays. Specific conditions for reactivity and signal detection should be optimized by the end user.

### **Background Information**

Anti-Rabbit IgG (H&L) peroxidase Antibody generated in chicken detects reactivity to Rabbit IgG. Secreted as part of the adaptive immune response by plasma B cells, immunoglobulin G constitutes 75% of serum immunoglobulins. Immunoglobulin G binds to viruses, bacteria, as well as fungi and facilitates their destruction or neutralization via agglutination (and thereby immobilizing them), activation of the compliment cascade, and opsinization for phagocytosis. The whole IgG molecule possesses both the F(c) region, recognized by high-affinity Fc receptor proteins, as well as the F(ab) region possessing the epitope-recognition site. Both the Heavy and Light chains of the antibody molecule are present. Secondary Antibodies are available in a variety of formats and conjugate types. When choosing a secondary antibody product, consideration must be given to species and immunoglobulin specificity, conjugate type, fragment and chain specificity, level of cross-reactivity, and host-species source and fragment composition.

### **Safety Information**

This reagent contains Gentamicin Sulfate (a poisonous and hazardous substance) as preservative. Although this concentration is not regarded as dangerous to health, appropriate measures should be taken to avoid skin and eye contact, inhalation, and ingestion. Standard Laboratory Practices should be followed when handling this material.DO NOT ADD SODIUM AZIDE! Use of Sodium Azide as a preservative will substantially inhibit the enzyme activity of horseradish peroxidase!
