Assay by immunoelectrophoresis resulted in a single precipitin arc against anti-Alkaline Phosphatase, anti-Rabbit Serum, Chicken IgG and Chicken Serum. No reaction was observed against anti-Pepsin or anti-Rabbit IgG F(c).

Background Information

F(ab')₂ Anti-Chicken IgG Antibody was generated by enzymatic cleavage and subsequent separation from the Fc fragment. Because of their smaller size, F(ab)₂ fragments offer several advantages over intact antibodies for use in certain immunochemical techniques and experimental applications. F(ab)₂ fragments penetrate tissue samples and show better antigen recognition and signal generation in IHC. F(ab)₂ fragments lack the Fc region and therefore do not bind Fc receptors which effectively lowers background staining. F(ab')₂ Antibody is ideal for investigators who routinely perform flow cytometry, immunohistochemistry or IHC and other immunoassays.
