Assay by immunoelectrophoresis resulted in a single precipitin arc against anti-peroxidase, anti-Rabbit Serum, Dog IgG and Dog Serum. No reaction was observed against anti-Pepsin or anti-Rabbit IgG F(c).

Storage Buffer: 0.02 M Potassium Phosphate, 0.15 M Sodium Chloride, pH 7.2	Store vial at 4° C prior to restoration. For extended storage aliquot contents and freeze at -20° C or below. Avoid cycles of freezing and thawing. Centrifuge product if not completely clear after standing at room temperature. This product is stable for several weeks at 4° C as an undiluted liquid. Dilute only prior to immediate use.

Background Information

F(ab')₂ Antibody was generated by enzymatic cleavage and subsequent separation from the Fc fragment. Because of their smaller size, F(ab)₂ fragments offer several advantages over intact antibodies for use in certain immunochemical techniques and experimental applications. F(ab)₂ fragments penetrate tissue samples and show better antigen recognition and signal generation in IHC. F(ab)₂ fragments lack the Fc region and therefore do not bind Fc receptors which effectively lowers background staining. F(ab')₂ Antibody is ideal for investigators who routinely perform flow cytometry, immunohistochemistry or IHC and other immunoassays.

Safety Information

This reagent contains Gentamicin Sulfate (a poisonous and hazardous substance) as preservative. Although this concentration is not regarded as dangerous to health, appropriate measures should be taken to avoid skin and eye contact, inhalation, and ingestion. Standard Laboratory Practices should be followed when handling this material. **DO NOT ADD SODIUM AZIDE!** Use of Sodium Azide as a preservative will substantially inhibit the enzyme activity of horseradish peroxidase!
