F(ab') ₂ Anti-GOAT IgG (H&L) (RABBIT) Antibody assay by immunoelectrophoresis resulted in a single precipitin arc against anti-Rabbit Serum, Goat IgG and Goat Serum. No reaction was observed against anti-Pepsin, anti-Rabbit IgG F(c) or Human Serum Proteins.

Background Information



F(ab')₂ Anti-Goat IgG Antibody was generated by enzymatic cleavage and subsequent separation from the Fc fragment. Because of their smaller size, F(ab)₂ fragments offer several advantages over intact antibodies for use in certain immunochemical techniques and experimental applications. F(ab)₂ fragments penetrate tissue samples and show better antigen recognition and signal generation in IHC. F(ab)₂ fragments lack the Fc region and therefore do not bind Fc receptors which effectively lowers background staining. F(ab')₂ Antibody is ideal for investigators who routinely perform flow cytometry, immunohistochemistry or IHC and other immunoassays. F(ab')₂ anti-Goat IgG antibody is ideal for investigators involved in Serum Protein Component research.
