Assay by immunoelectrophoresis resulted in a single precipitin arc against anti-Alkaline Phosphatase, anti-Goat Serum, Mouse IgM and Mouse Serum. No reaction was observed against anti-Pepsin or anti-Goat IgG F(c). No reaction was observed against other mouse heavy or light chain proteins.

Application Note:

F(ab')₂ Anti-Mouse IgM (mu chain) Antibody has been assayed against 1.0 ug of Mouse IgM in a standard capture ELISA using ABTS (2,2'-azino-bis-[3-ethylbenthiiazoline-6-sulfonic acid]) code # ABTS-100 as a substrate for 30 minutes at room temperature. A working dilution of 1:2,000 to 1:8,000 of the reconstitution concentration is suggested for F(ab')₂ Anti-Mouse IgM (mu chain) Antibody.

Background Information

F(ab')₂ Anti-Mouse IgM (mu chain) Antibody generated in Goat detects specifically Mouse IgM mu heavy chain. F(ab')₂ Antibody was generated by enzymatic cleavage and subsequent separation from the Fc fragment. Because of their smaller size, F(ab')₂ fragments offer several advantages over intact antibodies for use in certain immunochemical techniques and experimental applications. F(ab')₂ fragments penetrate tissue samples and show better antigen recognition and signal generation in IHC. F(ab')₂ fragments lack the Fc region and therefore do not bind Fc receptors which effectively lowers background staining. F(ab')₂ Antibody is ideal for investigators who routinely perform flow cytometry, immunohistochemistry or IHC and other immunoassays.
