Assay by immunoelectrophoresis resulted in a single precipitin arc against anti-Rabbit Serum, anti-Alkaline Phosphatase, Swine IgG and Swine Serum. No reaction was observed against anti-Pepsin and anti-Rabbit IgG F(c).
